DEFENDANT ARIEL QUIROS'S RESPONSE TO MOTION BY LEON COSGROVE AND MITCHELL SILBERBERG & KNUPP TO MODIFY ASSET FREEZE THAT THE SEC AND THE RECEIVER DO NOT OPPOSE

Defendant Ariel Quiros, through undersigned counsel, files this Response to Motion by Leon Cosgrove and Mitchell Silberberg & Knupp to Modify Asset Freeze that the SEC and the Receiver Do Not Oppose and states:

As stated in Mr. Quiros's Response to Mitchell Silberberg & Knupp and Leon Cosgrove's Motion to Modify Asset Freeze (ECF No. 408), Mr. Quiros agrees that payment of defense costs under an insurance policy may be made free of the asset freeze. However, those law firms are not entitled to any payment under Ironshore's contract with Mr. Quiros, and, therefore, the issue of whether any such payments are subject to the asset freeze should not be before this Court. As also stated in Mr. Quiros's Response, Mr. Quiros opposes the payment of any fees to those law firms pursuant to the IFA on the grounds, *inter alia*, that the fees sought by those firms are unreasonable.

Accordingly, Mr. Quiros does not oppose the law firms' dismissal of their appeal nor their withdrawal of their pending Motion to Modify Asset Freeze (ECF No. 284). Mr. Quiros does oppose the entry of the proposed order submitted to the Court to the extent that the proposed order

states, in paragraph 2, that Ironshore Indemnity, Inc. ("Ironshore") is allowed to pay any amount

to LC and MSK under the IFA. Mr. Quiros submits the attached alternative proposed order

addressing the foregoing issue, attached hereto as Exhibit A.

WHEREFORE, Defendant Ariel Quiros respectfully requests grant the Motion solely to

the extent that it permits dismissal of the appeal and withdrawal of the pending Motion to Modify

Asset Freeze (ECF No. 284), deny the Motion to the extent it requests any ruling from this Court

regarding payment of fees to the law firms pursuant to the Agreement between Ironshore and Mr.

Quiros, and enter the attached proposed order.
